Explanation of Responses:

- As previously disclosed on October 20, 2023, the reporting person informed Viatis Inc. ("Viatis") of his intention to retire from his executive role with Viatis effective as of April 1, 2024 and agreed to remain a member of Viatis' Board of Directors. As a non-employee director, the reporting person is eligible to participate in Viatis' non-employee director compensation program. Represents restricted stock units (RSUs) granted for such service, consistent with the grants provided to Viatis' other non-employee directors.
- Each RSU represents the right to receive one share of common stock of Viatis. These RSUs will vest on March 4, 2025.
